The Royal Falcon One is the world's first Mega-Yacht fully designed by Porsche Studio teaming up with us to benefit from our successful background and our trusted influence to help give the Royal Falcon one a new launch with stronger exposure directly to the Royal Families and the elite society around the world.

The Royal Falcon One is a brand-new 134ft 98in power catamaran with a beam of 12.5 meters and a draft of 1.7 meters and an all-aluminum superstructure with a voluminous interior and was manufactured in Sweden custom-built to Lloyd's Register classification, under Cayman Island Flag and is also compliant with commercial operations. The yacht has a 1,200nm range at a cruising speed of 15 knots and has a top speed of 37 knots given by nearly 10,000 horse powers from two 16V 4000 MTU diesel engines with MJP waterjets.

The Royal Falcon One features twin 4,600 horsepower diesel engines and twin Rolls-Royce KaMeWa waterjets, delivering a cruising speed of around 15 knots and can go up to 35 knots whilst designed for low fuel consumption, with a range of 3,200km. On the main deck, the saloon is the heart of the yacht and is the natural place for guests to gather. Entering from the aft deck, one is immediately struck by the size of the 12.5m beam. Rather than one single lounging area, the saloon offers a variety of sitting areas conducive to smaller groups pursuing different activities at once. Moving forward through the main Media corridor, one enters the main guest area which houses 3 luxurious VIP suites and, in the front, the Panoramic Lounge with the entertainment area, bar and offers the perfect settings for unwinding and relaxing while enjoying the view of the sea. On mid deck level, the masterpiece owner's suite and balcony with a luxury bathroom. Mid deck level also houses 1 luxurious VIP suite, the Captain's cabin and the main control bridge. The owner's balcony opens onto a panoramic view to stern, port- and starboard side views with a total accommodation for 10 guests, comprising of the owner's suite and 4 VIP suites. The upper level (fly bridge) has a jacuzzi pool surrounded of lying down beds, a bar and outdoor bridge to command the yacht.

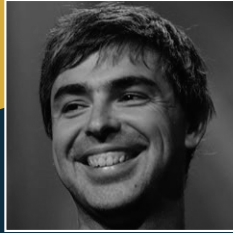

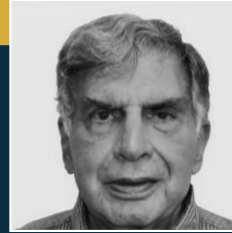
